COMMERCIAL ENROLLMENT, BY REGULATOR AND PRODUCT TYPE



ENROLLMENT, BY MARKET, 2019 (IN MILLIONS)




ENROLLMENT, BY INSURER AND MARKET, 2019 (IN MILLIONS)
