Telecare Corporation is a **behavioral health organization** that hires and prepares unlicensed professionals to participate within multidisciplinary community-based and inpatient programs in **more than 20 California counties** that support individuals living with behavioral health challenges, including persistent mental illness and substance use.

The organization **employs more than 1,500 unlicensed professionals in California (thirty-five percent of its workforce)** in almost **fifty distinct roles** (including recovery specialists, substance use counselors, case managers, personal services coordinators, mental health workers, rehabilitation activity leaders, crisis intervention specialists, and peer health navigators). This community-connected workforce discharges responsibilities that overlap with those of a CHW/P working in a health care setting. This community-connected workforce contributes to member engagement, care planning and coordination, housing stabilization, health care navigation, and health coaching.

Telecare recruits and hires for experience, then prepares its new employees through training, shadowing, and supervision. All new employees working within its community-based programs engage in **almost 70 hours of training** over the first year of employment. This training is mostly online, with supplemental in-person skills practice. The training includes 11 hours on chronic disease, 2 hours on co-occurring conditions and recovery, and 5 hours learning stage-matched interventions and motivational interviewing strategies.

The organization provides **opportunities for additional training and advancement**, with more than 4 levels of advancement within some roles as well as a recently created program administrator position that does not require licensure.

Telecare's **standardized training for all employees delivering services in the community** is listed on the next 4 pages, followed by a list on the final page of job titles into which it hires an unlicensed workforce.
